YOUNG ADULT STUDENTS AGES 15 THROUGH 22 LEARN TO FUNCTION INDEPENDENTLY THROUGH THE LIFE SKILLS CENTER.

THE EMPLOYMENT ACADEMY HELPS THOSE STUDENTS 14 THROUGH 22 TRANSITION INTO THE WORK PLACE THROUGH INTERNSHIPS IN THE COMMUNITY.

ADULT SERVICES ENCOMPASSES THE FAISON RESIDENCE; ADULT DAY SERVICES; AND THE FAMILY PARTNER PROGRAM. THE FAISON RESIDENCE IS A COMPASSIONATE COMMUNITY ALLOWING INDIVIDUALS WITH SPECIAL NEEDS TO TRANSITION FROM A TYPICAL DAY SCHOOL TO A MORE INDEPENDENT LIFESTYLE IN ADULTHOOD. THE FAISON RESIDENCE PROVIDES A SEMI-INDEPENDENT LIVING COMMUNITY CONSISTING OF APARTMENTS AS WELL AS A COMMUNITY ROOM AND RECREATIONAL FACILITIES FOR SOCIAL ACTIVITIES.
