The primary program is undergraduate instruction in the liberal arts leading to a Bachelor of Arts degree. The curriculum includes programs in the arts, sciences, social sciences and humanities. The program emphasize academic breadth and depth supported by essential foundational skills, such as critical thinking, clear communication, and careful analysis and synthesis of information, that are relevant in every line of work and study. Of the 6,595 applicants who applied for admission to the Class of 2019, 37 percent were accepted and 738 enrolled. Approximately 24 percent of the class is African-American, Latin American, Asian-American and Native American. Students come from 35 states and 10 countries. Men represent 48 percent of the class and women 52 percent with a total full time enrollment of 2,885 with 699 of those students graduating in May 2016.

A committee appointed by the President of the College administers the incentive plan. The committee determines each participants annual incentive opportunities which vary based upon achievement of specified levels of performance for the plan year. Factors for determining incentive opportunities include benchmarking endowment returns, ranking against endowment pools of comparable organizations, net return on the endowment pool, completion of annual goals, leadership competencies and overall performance in major areas of responsibility. Timothy Jarry earned 80,368 in deferred compensation as part of the incentive plan which is included in Part II column C.
Part I Line 4b	The College has established a voluntary early retirement program for tenured faculty members who have completed fifteen years of service and attained the age of sixty-two. Eligible faculty members are entitled to a percentage payout that decreases with age. In addition, eligible faculty members are able to remain enrolled in the Colleges available medical health plans. Robert Cording retired in August 2015 and received 197,220 in other reportable compensation as part of the Colleges early retirement program. There are no other amounts to be paid.
Part II	Members of the Society of Jesus take a vow of poverty. Compensation is paid directly to their order which is exempt under Section 501c3. Under Rev.
