The School partners with School and Student Service for Financial Aid (SSS) for the application process, which includes a full personal financial statement and two years of federal tax returns and W-2's. SSS provides an independent assessment of what the family can contribute towards educational costs. All financial grant awards are based on need as determined by the Financial Aid Committee using all information obtained in the application and from SSS. Once the Financial Aid Office receives all financial materials pertaining to the application, the Committee will review each family's request. Consideration for aid is made after a student has been offered a place at Brimmer and May. Once the award has been given and the student enrolls at the School, the Business Office is given the amount of the award to process against the student account. These funds are part of the School's operating budget and the Business Office produces reports in order to verify against the final financial aid reports to student billing.
