Over the past 100 years, Forsyth has evolved into an innovative center for biomedical research. Many of Forsyth's scientists use the mouth as a portal to learn more about the body, and are examining how bone loss occurs and how inflammation contributes to systemic diseases such as diabetes and heart disease. Others are investigating the roles that bacteria in and on the human body (our microbiome) play in health and disease - from cavities to pneumonia. The institute's founding public health mission remains strong through the ForsythKids program, a novel mobile service deliverng dental care to thousands of underserved children annually.
