THE SCHOOL RECORDS THE EXPENSE IN THE YEAR IT IS EARNED. DEFERRED COMPENSATION TOTALING \$227,500 IS INCLUDED IN ACCOUNTS PAYABLE AND ACCRUED EXPENSES AS OF JUNE 30, 2016.
