The grant is on a cost reimbursement basis for allowed program expenditures. The period of the grant will be from February 1, 2015 through January 31, 2017 with the maximum amount of the grant to be approximately \$164,800. The Association acts as an agent under the grant in which it submits requisitions for reimbursable costs to Commonwealth Corporation. Upon receipt of the grant funds, the Association will transfer these funds to the Foundation to be used for the purpose of the grant. During the years ended June 30, 2016 and 2015, the Foundation collected \$67,465 and \$5,823, respectively, of grant funds from the Association, which is reflected in the statement of revenue, expenses and changes in net assets as temporarily restricted grant income. Grant expenses incurred during 2016 and 2015 were \$93,326 and \$67,716, respectively. Included in grant expenses are reimbursements to the Association for costs incurred under the grant. Subsequent to June 30, 2016, the Foundation collected \$87,755 from the Association in connection with this grant.</p> |
