In the 2015-16 academic year, New Hope Tutorials offered 25 full-year courses to a total of 130 students from 78 families in 6 core subjects. 11 of our students graduated this year, most of them going on to attend four-year colleges. New Hope Tutorials also provided "short courses" in writing, math and art, a comprehensive SAT Prep class, 7 additional workshop subjects for various ages, running 6-12 weeks, and extra-curricular activities, including field trips to cultural and historical sights.
