4 Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. Section 501(c)(3) and 501(c)(4) organizations are required to report the amount of grants and allocations to others, the total expenses, and revenue, if any, for each program service reported.

The BAA has managed and operated the Boston Marathon continuously since 1897. The BAA, through the Boston Marathon - Promotes health, fitness, and an overall healthy lifestyle by encouraging the public to train for and run in the Boston Marathon and seeking to help in the development of skilled U.S. distance runners who can aspire to compete internationally, benefiting the cause of athletics and fitness - Assists marathon runners to fundraise for many charitable organizations, many of which promote health and fitness, conduct research aimed at treating and eradicating disease, and which provide healthcare treatment to persons afflicted with serious diseases. The Boston Marathon Charity Program enables selected charitable organizations to raise millions of dollars for worthwhile causes. In 2016, the program surpassed the \$264 million mark in total funds raised since its inception in 1989 - Assists in the generation of approximately \$189 million in marathon-related revenues (as determined by the Greater Boston Convention and Visitors Bureau) for the local economy, in direct connection with the weekend's events surrounding the annual conduct of the Boston Marathon.

operation and management of other event and programs that promote health and fitness, including - The conduct of additional long distance running events, open to the public, in the Boston area These include the events comprising what is known as the BAA Distance Medley - The BAA 5K, a 3 1 mile road race held in Boston annually on the Saturday of Boston Marathon weekend involving 10,000 participants - The BAA 10K, a 6 2 mile road race conducted in Boston annually in late June involving 10,000 participants, and - The BAA Half Marathon, a 13 1 mile road race conducted in Boston annually during the second weekend in October involving 9,500 participants These events include a prize money structure for the professional athletes who compete in them (described below), but are also designed to appeal to members of the public who desire to improve their fitness and health The events comprise a "Fitness CALENDAR" for the year, such that individuals can begin the spring with a modest distance 5K race, progress in June to a longer race, and then in the fall be prepared to run a half marathon These events also allow members of the public to compete alongside some of the finest runners in the world For professional athletes in the Distance Medley the prize money awarded in the series includes a purse for each race and bonus incentives for the top finishers in the individual events and for event record times set at these events To increase competition across Distance Medley events, the bonus structure was revised in 2015 to offer race-by-race bonus incentives rather than one-time payouts made to top male and female finishers Distance Medley expenses are recorded in the statement of activities and changes in net assets within the applicable race expenses in proportion to the revenue earned by each race in the Distance Medley - In 2013, the BAA added a high performance component to its already-existing BAA Running Club This group comprises an elite team of 8-12 American runners supported by the organization at the level necessary to accomplish the highest athletic pursuits within the sport of running, such as making world championship and Olympic teams The establishment of the high performance team is consistent with the BAA's mission of promoting athletics through running - In 2015, the BAA IN COLLABORATION WITH ADIDAS AND MARATHON SPORTS INC LAUNCHED BOSTON MARATHON ADIDAS RUNBASE (BMARB) BMARB IS THE FIRST OF ITS KIND STATE OF THE ART HUB EXCLUSIVELY FOR RUNNERS IN THE BOSTON AREA AND IT SEEKS TO BECOME THE CENTER OF RUNNING IN BOSTON BMARB SERVES AS A HOST FOR EVENTS, CLINICS, COMMUNITY SPACE AS WELL AS A MEETING SPACE FOR RUNNERS THE BAA BELIEVES BMARB WILL HELP EDUCATE AND INFORM A NEW GENERATION OF RUNNERS AND TOURISTS IT IS LOCATED AT THE 26TH MILE MARK ON BOYLSTON STREET ALONG THE HISTORIC MARATHON COURSE - The BAA Running Club, which provides coaching, training and competitive outlets for its 250 members The club is a 52-week per year effort which includes practices, workouts, racing and volunteer actions - Training clinics and seminars that assist individuals in training and preparing for athletic competition and in pursuing a healthy lifestyle generally - Club 120 is a program that allows middle school aged children from the cities and towns along the Boston Marathon route and surrounding communities the opportunity to train and compete as relay teams in Boston on Marathon weekend in the BAA Relay Challenge, thereby promoting the health and fitness of those children and others in their communities and elsewhere More than 900 children participated, and over 21,000 have participated since the inception of the program - Coordination and staging of the Boston Middle School Cross Country Program involving students from 13 Boston Public Schools The multi-week program culminates in championship races in Franklin Park in Boston, and is intended as an inspirational introduction to the sport and a healthy lifestyle Additionally, since 1997 the BAA annually supports and sponsors the Boston Mayor's Cup Cross Country and Youth Races at Franklin Park in Boston This event has 1000 competitors, including Olympic level athletes but is also a grassroots initiative geared towards local area runners of all ages and abilities - Finally, The BAA and the Dimock Community Health Center have collaborated to establish a 5K neighborhood race known as the "Road to Wellness " As one of Massachusetts' largest community health centers their aim is to promote a healthy lifestyle for the residents of Roxbury and the surrounding area The reach of the event extends beyond the day of the race itself, through a multi-week period of training and brings the community together for the 5K race in familiar streets
