THE RESTATEMENT OF THE UFRS RESULTED IN A LIABILITY TO THE COMMONWEALTH TOTALING \$165,637. THESE AMOUNTS ARE INCLUDED IN LOSS - UNSUBSTANTIATED EXPENSES FOR THE YEAR ENDED JUNE 30, 2016. IN ADDITION, THE UNSUBSTANTIATED EXPENSES FOR FISCAL YEAR 2016 TOTALLED \$75,650 AND ARE REFLECTED AS UNSUBSTANTIATED EXPENSES. THESE AMOUNTS INCREASED THE LIABILITY DUE TO THE COMMONWEALTH BY \$62,818 TO \$228,455 AS OF JUNE 30, 2016. MANAGEMENT HAS FILED A CLAIM FOR REIMBURSEMENT WITH THE LIFELINKS' INSURANCE CARRIER PERTAINING TO THE AFOREMENTIONED LOSSES. THE RESULT OF THE CLAIM IS NOT DETERMINABLE AT THIS TIME. ACCORDINGLY, NO AMOUNTS ARE REFLECTED IN THE ACCOMPANYING FINANCIAL STATEMENTS PERTAINING TO THE POTENTIAL RESULT OF THE CLAIM.
