DURING THE FISCAL YEAR, WHICH ENDED ON JUNE 30, 2016, THE FOOD BANK DISTRIBUTED A RECORD 9.2 MILLION POUNDS OF FOOD TO ITS 178 MEMBER AGENCIES WITH 119 PROGRAM SITES. MOST OF THE FOOD DISTRIBUTED, 89 PERCENT, WAS CORE, NUTRITIOUS FOOD INCLUDING FRESH PRODUCE, GRAINS, PROTEIN AND DAIRY PRODUCTS

IN FISCAL YEAR 2016, THE FOOD BANK OPERATED THREE KIDS CAFE SITES IN THE HIGH-NEED CITIES OF PROVIDENCE, CENTRAL FALLS, AND EAST PROVIDENCE IN COLLABORATION WITH EXISTING AFTER SCHOOL PROGRAMS IN EACH COMMUNITY. THE PROGRAM PROVIDED OVER 23,000 MEALS & SNACKS DURING THE PAST YEAR.

COMMUNITY KITCHEN IS A CULINARY JOB-TRAINING PROGRAM FOR ADULTS TRANSITIONING INTO THE WORKFORCE. STUDENTS CREATE NUTRITIOUS MEALS FOR DISTRIBUTION TO THE KIDS CAFE AFTER SCHOOL MEAL PROGRAM. DURING THE YEAR ENDING JUNE 30, 2016, THE FOOD BANK CONDUCTED THREE COMMUNITY KITCHEN CLASSES. A TOTAL OF 30 STUDENTS GRADUATED FROM THE PROGRAM. WITHIN THREE MONTHS OF THEIR GRADUATIONS, APPROXIMATELY 83 PERCENT HAD SECURED EMPLOYMENT IN THE FOOD SERVICE INDUSTRY.
