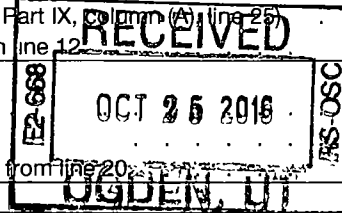

**Green Infrastructure Coalition:** A coalition of about 40 member organizations focused on management of stormwater in Rhode Island. ECRI Education Fund is the Fiscal Agent for the coalition. Work includes advocacy for the creation of Stormwater Utility districts, research on best practices, research on the use of stormwater to benefit wildlife populations including amphibian breeding habitat, and the creation of small stormwater management infrastructure. Almost all of the work of the coalition is undertaken by the various coalition members. ECRI Ed Fund holds the grants and distributes funds to the various member organizations and for programs like the green infrastructure bus tour of Providence.

**Energize Rhode island:** A coalition of five organizations. The ECRI Ed Fund serves as the Fiscal Agent. The purpose of the coalition is to educate Rhode Islanders and RI policy leaders about how properly pricing carbon emissions would benefit Rhode Island.
