More kids are doing better in school and life. The statistic is startling. 90% of New Haven students have been exposed to trauma. Research shows that exposure to trauma can have long term effects - developmental delays, neurological damage, and chronic diseases - and that we can take actions to protect children and build resiliency. United Way and community partners launched the New Haven Trauma Coalition to provide a versatile approach within schools that includes yoga, meditation, and dancing, as well as clinical workers. This focus on prevention helps children avoid bigger issues down the road. Through United Way's work in the New Haven Trauma Coalition we have served 2,366 students this past school year.

More children are nurtured and families are thriving. United Way works as a backbone organization, a service provider, a convener, and a funder to support our community agenda for change. These efforts combat hunger and homelessness (Neighbor to Neighbor and Greater New Haven Coordinated Access Network), improve financial stability for families (Volunteer Income Tax Assistance and New Haven Secure Jobs), and increase the capacity of public and private service providers to achieve better results for the people they serve (Secure Start, Your Money Your Goals, Service Delivery Improvement Initiative, and New Haven Two Generation Initiative). In addition to executing on our community change goals, United Way generates, manages, and distributes significant financial resources for the region. United Way raises financial resources year round through workplace-based and community campaigns, as well as through government and foundation grants. Donor-designated funds raised from Greater New Haven workplace campaigns support a broad base of non-profits. United Way's fundraising activities rely on a significant effort by community volunteers.
