BEHAVIORAL HEALTH SERVICES Lifebridge provides support services for HIV/Aids patients, counseling and education for the Behavioral Health Services, including domestic violence and parent education programs. During fiscal year 2015-2016 Outpatient Behavioral Health Services were expanded to a second site in Fairfield as of April 1, 2016 Behavioral Health provided a record breaking number of 26,269 outpatient sessions to Lifebridge clients during the time period of July 1, 2015 - June 30, 2016

ECONOMIC EMPOWERMENT INITIATIVE Lifebridge works with other agencies to improve financial budgeting, secure and maintain housing, improve employment and entrepreneurial skills, prepare individuals for better jobs, and meet some basic needs. During the 2015-2016 fiscal year, Lifebridge Community Service Serviced thousands in conjunction with Connecticut Council of Family Service Agencies, Connecticut Department of Housing and the Connecticut Departments of Labor and Social Services. During 2015-2016 fiscal year, Lifebridge had 353 referrals to empowering people for success. The program focused on helping low-income parents become more stable, reducing the likelihood of harm occurring with their children. Housing stabilization kept 732 families in stable homes. VITA served 683 families, preparing 707 tax returns, generating \$513,444 in earned income tax credits and securing tax refunds totaling \$1,482,311. In addition, 27 students graduated from Workshop in Business Opportunities. A total of 83 households were screened for benefits, predominately food stamps and medical insurance. During 2015-2016, 52 nursing home residents were successfully transitioned to live more independently in accessible housing. Work skills programs served 85 clients providing them customer service training, job readiness and skill building programs and certifications. The Community Closet provided clothing and household goods to 2,161 clients and their families. Additionally, 114,166 disposable diapers were distributed to 319 families in partnership with the diaper bank.

LIFEBRIDGE'S TWO Social Enterprise programs-Food Services and Deaf Outreach and Interpreting Services-provide essential services to some of our most vulnerable community members. This year, our Food Service provided 268,769 home delivered meals to 1,264 clients and 112,683 congregate meals to 3,255 clients. Lifebridge's Outreach and Interpreting Services program provided 18,588 sign language interpretive hours to 790 deaf and hearing impaired individuals across the state. Fresh connections launched with its first delivery to 13 clients.
