THE ACADEMIC PROGRAM IS ENHANCED BY A SKILLS BASED TEACHING AND ASSESSMENT PROGRAM, ABILITY BASED EDUCATION, AND AN INTEGRATIVE LEARNING EXPERIENCE THAT PROVIDES PROFESSIONAL, INDUSTRY-SPECIFIC EXPOSURE WITH FACULTY GUIDANCE TO SUPPORT STRONG CAREER DEVELOPMENT.
