Honduras- Asociacion Compartir More than 5,000 children and youth benefitted from the mobile library activities, participating in programs including film, storytelling, dramatizations, expositions, and research projects. Without JustWorld, many of those served by the mobile library would not have access to any educational activities as they live too far to attend school or cannot afford the required uniforms, books and school supplies. More than 8,000 snacks were provided to the children and youth who participated in the activities generated through the JustWorld project, encouraging participation and often the only source of sustenance they may receive that day. Compartir also offered theatre, flute, band, percussion, and artistic workshops along with a science fair, and field trips to the National Theatre, broadening their horizons and education and providing opportunities to succeed and become good citizens

Guatemala- Los Patojos Los Patojos provided 250 students the opportunity to attend school, full-time, from Pre-Kindergarten through 7th Grade. Los Patojos served 48,845 lunches in addition to breakfast and dinner each school day. The additional meals have helped students become healthier and reach targeted height/weight ratios. The on-site physician, Dr. Hector Valle, served more than 1,539 patients in the clinic, visiting three times a week to provide care to students and their families as well as members of the community who cannot afford care at the local clinics. Los Patojos' cultural program was carried through to all grade levels, providing opportunities for all children to participate in break dance, guitar, singing, marimba, music, painting/photography, theatre, juggling, politics, educational workshops and journalism. Through these programs they gain addition to gaining new skills, they develop confidence, team work, self-esteem, and values which aid youth in attaining jobs and becoming successful adults

Cambodia - People Improvement Organization (PIO) JustWorld supported 850 students at PIO in Kindergarten through 6th Grade. All students received uniforms and school supplies and spent one hour per week in the library reading English or Khmer books. Attendance rates remained high- 90% at the beginning of the year and contributing to high pass rates 100% of the 6th grade students passed their high school entrance exams, exceeding the previous year. All students received a nutritious lunch each school day comprised of rice, vegetables, and meat or fish as well as 5 kilograms of rice per month. The PIO nurse cared for approximately 300 students each month. 37 students, 24 female and 13 male, continued to participate in the Apsara dance classes. They trained every Sunday and performed for a number of visiting schools as well as Maybank executives and for the Khmer New Year celebrations
