THE STAFF THEN GATHERS THE REPORTS, REVIEWS THEM AND WRITES A CONFLICT OF INTEREST MEMO STATING THE NUMBER OF COI REPORTS WITH NO CONFLICTS, LISTING MISSING AND OUTSTANDING COI REPORTS AND SUMMARIZES THE REPORTS WITH POTENTIAL AND ACTUAL CONFLICTS OF INTEREST INCLUDING IN-DEPTH INFORMATION REGARDING THE CONFLICT AND RECOMMENDATIONS FOR RESOLUTION OF THE POTENTIAL OR ACTUAL CONFLICT OF INTEREST. THE STAFF SENDS THE MEMO ALONG WITH COI REPORTS CONTAINING CONFLICTS TO THE AUDIT COMMITTEE AND GOVERNANCE COMMITTEE. THE GOVERNANCE COMMITTEE REVIEWS THE MEMO, CONFLICT OF INTEREST REPORTS AND RECOMMENDATIONS FOR RESOLUTION AND DETERMINES THE APPROPRIATE COURSE OF ACTION UNDER THE CONFLICT OF INTEREST POLICY. THE DETERMINED COURSE OF ACTION IS REPORTED TO THE INTERESTED PARTIES. THE GOVERNANCE COMMITTEE ALSO REPORTS EACH CONFLICT AND RESOLUTION TO THE DIRECTORS OF THE
