THE STRENGTH OF MOCADA'S GUEST CURATORS PROGRAM HAS RESULTED IN AN INNOVATIVE LINE-UP OF SHOWS FOR THE MAIN GALLERY, AND NEW RELATIONSHIPS WITH EMERGING AND TALENTED CURATORS AND ARTISTS. COMMUNITY PROGRAMS AT MOCADA BRING THE ARTS TO THE PEOPLE, RIGHT WHERE THEY ARE. THE MUSEUM SPACE SERVES AS AN IMPORTANT HUB FOR CONNECTION AND PRESENTATION, AND A PHYSICAL ARCHIVE OF THE GENERATIVE IMPACT OF BLACK ARTS IN THE NEIGHBORHOOD, BOROUGH, CITY, AND BEYOND.
