Laboratories are loosely clustered in six research areas, including biochemistry, structural biology, and chemistry, medical sciences and human genetics, molecular, cell, and developmental biology, immunology, virology, and microbiology, neuroscience, and physics and mathematical biology. The University does not charge tuition. Its revenues are derived primarily from investment income, government grants and contracts, and private gifts and grants.
