THE ORGANIZATION'S EAP IS COMPRISED OF FOUR FUNDS: THE GLOBAL HUMAN RIGHTS DEFENDERS FUND, THE LIFELINE EMBATTLED CSO ASSISTANCE FUND, DIGNITY FOR ALL: THE LGBTI ASSISTANCE PROGRAM, AND THE RELIGIOUS FREEDOM FUND. WITH THESE FUNDS, THE ORGANIZATION PROVIDES SMALL, RAPID RESPONSE GRANTS TO HUMAN RIGHTS DEFENDERS (HRDS) AND CIVIL SOCIETY ORGANIZATIONS (CSOS) THREATENED BECAUSE OF THEIR HUMAN RIGHTS WORK, AND TO SURVIVORS OF SEVERE RELIGIOUS PERSECUTION. CASES ARE RECEIVED THROUGH A VAST REFERRAL NETWORK, INCLUDING LOCAL, REGIONAL, AND INTERNATIONAL PARTNERS.
