The Mental Health Law Project assists individuals with mental illness living in apartments in their communities and in adult care facilities, by providing advocacy services, consultation, advice, direct representation and trainings. Disability and Aging Rights Project provides advocacy and trainings to people with disabilities and who are aged and pursues individual and affirmative litigation on issues that impact them.

Foreclosure Prevention Project provides legal assistance for New York City homeowners facing foreclosure or who are victims of foreclosure rescue scams or abusive loan servicing practices. The project focuses on helping homeowners in Queens, Brooklyn, and Staten Island, NY.
