Compensation is determined by terms of employment agreements (if any), the organization's performance, the employee's contributions to that performance and his or her years of service. Additional factors considered are education or credentialing, prior experience, current and prior affiliations, scarcity of talent in job area, etc. Decisions on compensation for members of the Ability Beyond Disability senior management team are reached after review of the relevant survey information and data for like positions in like agencies in the region. Members of the senior management team whose compensation is being considered are not present at the meetings at which a decision on his or her compensation is reached.
