KCE trained 252 doctors in both hospitals on the use of PEMSoft. PEMSoft mobile software for their smartphones was distributed to all the trained doctors, and PEMSoft software was installed on the hospital's computer system for all doctors and medical professionals to use. Cali, Colombia: In 2016, KCE visited Foundation Clinica Infantil-Club Noel in Cali. Numerous training sessions were held for attending doctors. All attendees received PEMSoft mobile application for their smartphone, and the PEMSoft software was installed and upgraded on the hospitals main computer for all doctors to use.
