Trustee James Tyler is president and owner of Northland Associates which owns JDS Construction. In 2016, the university solicited proposals for renovations to its riding arena. After careful review by senior management and the board, JDS Construction was selected for the project and the university entered a contract in the amount of \$191,765. In 2016, Mr. Tyler made a charitable donation of \$5,000 and Northland Associates made a charitable donation of \$45,000.
