**This was used to support the education of Afghan children in the main center in Kabul as well as IDP (internally displaced persons) camp in Kabul. Funds were used for teacher salaries, supplies and building maintenance. More than 2,800 children were helped at the center; 300 were supported in IDP camps.**

4b (Code: ) (Expenses \$ 50,605 including grants of \$ ) (Revenue \$ )

**These funds were provided to families as payment to replace money their children would have earned working on the streets. By giving families a stipend, this allowed 151 children to attend school full time to get to grade level and matriculate to regular public schools.**

4c (Code: ) (Expenses \$ 45,825 including grants of \$ ) (Revenue \$ )

**This program provided 255 students in Mazar-i-Sharif and 200 students in Gardez twith basic remedial education to get them to grade level to matriculate to the regular public school system. The funds were used for teacher salaries, classroom rental space and school supplies.**
