SHEPHERDS THEOLOGICAL SEMINARY IS AN ACCREDITED GRADUATE SCHOOL PROVIDING QUALITY ACADEMIC AND THEOLOGICAL TRAINING FOR STUDENTS DESIRING TO SERVE IN LEADERSHIP ROLES AT CHURCHES, NON-PROFITS, AND OTHER FAITH-BASED ORGANIZATIONS. DURING THE 2015-2016 ACADEMIC YEAR, STS WAS ENGAGED IN GRADUATE EDUCATION AT THREE SITES. AT ITS CARY, NC CAMPUS, STS PROVIDED A TOTAL OF 72 COURSES RANGING FROM 1 TO 13 STUDENTS ENROLLED. IN TOTAL, THE FOLLOWING NUMBERS OF STUDENTS PARTICIPATED IN PROGRAMS AT STS: 78 GRADUATE STUDENTS (DEGREE/CREDIT SEEKING) AND 33 NON-DEGREE-SEEKING/AUDIT STUDENT. STS DELIVERED 1279 TOTAL CREDIT HOURS OF INSTRUCTION, OF WHICH 28 CREDITS WERE TAUGHT VIA DISTANCE EDUCATION. STS HAD 26 GRADUATES IN MAY 2016 WHO ARE PARTICIPATING IN A VARIETY OF MINISTRIES, INCLUDING THE FOLLOWING: PASTORS, ASSISTANT PASTORS, CHURCH PLANTERS, MISSIONARIES, BIBLICAL COUNSELORS, LAY-COUNSELORS, NON-PROFIT WORKERS, AND LOCAL-CHURCH VOLUNTEERS.
