Twin Cities Academy High School provides a comprehensive program of instruction to students in grades nine, ten, eleven, and twelve. During the fiscal year ended June 30, 2016, Twin Cities Academy High School served an estimated 245 students.

The Academy's Board passed a resolution to merge with Twin Cities Academy (Middle School). The merger was approved by the University of St. Thomas, the authorizer for both schools. Effective July 1, 2016, Twin Cities Academy (Middle School) ceased to exist as a separate legal entity, and all assets and obligations of the Academy were assumed by the merged organization, Twin Cities Academy, FKA: Twin Cities Academy High School.
