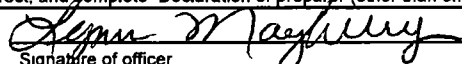

During 2016, Child Protect conducted a record number of forensic interviews (282) with suspected child abuse victims. We coordinated and provided 44 forensic medical exams for child sexual assault victims. 17 Child Protect cases resulted in criminal charges against suspected child abuse perpetrators with 12 indictments. 6 Child Protect cases ended in criminal convictions or plea bargains. Child Protect staff coordinated mental health services for 103 trauma survivors. We provided advocacy & support services to a total of 324 children over the course of the year. Lastly, we provided child abuse prevention programming to 3,606 students in Mercer County schools during the 2015-2016 school year.
