MfA Fellowship is for recent college graduates who train for a year and then join a corps of teachers who make a four year commitment to teach in NYC public schools. Early Career fellowship is for math and science teachers in their first few years of teaching who join the MfA corps. Master Teacher fellowship is for exceptional math and science teachers in mid/advanced stages of their career who join the MfA corps and lead within the community. School Leader Fellowship is for Principals and other school-level supervisors who have a deep commitment and knowledge of math and science and work to support those departments within their respective schools. All Fellowships provide extensive professional development and generous stipends for members of the community.

Math for America also connects other programs by creating a network of sites that are modeled on the Math for America program in New York City. All these SITES ARE DEVOTED TO IMPROVING MATH AND SCIENCE EDUCATION IN U.S. PUBLIC SCHOOLS BY BUILDING COMMUNITIES OF HIGHLY ACCOMPLISHED STEM TEACHERS, BOTH NOVICE AND EXPERIENCED, PROVIDING TEACHERS WITH OPPORTUNITIES TO GROW PROFESSIONALLY. THE SITES CURRENTLY INCLUDE BOSTON, LOS ANGELES, SAN DIEGO, WASHINGTON D.C., BERKELEY, UTAH, AND NEW YORK STATE. THE GOAL OF Math For America IS TO EXPAND THIS NETWORK TO INCLUDE SIMILAR PROGRAMS ACROSS THE NATION.

Math for America promotes the importance of K-12 mathematics and science teachers who know the subject they are teaching and who are also professionals in teaching. The organization's goal is to change the perception of the teaching profession and to encourage the best teachers to stay in the classroom and amplify their impact. MA serves as a model, inspiring a network of Master Teacher programs in cities and states across the country. Much of the outreach work is addressed at the national level, to encourage an expanded corps of highly qualified STEM teachers throughout the nation and not merely in MA related programs.
