THE WOMEN'S FUND FOR THE FOX VALLEY REGION PROVIDED 45 GRANTS TO 25 DIFFERENT ORGANIZATIONS TO PROVIDE LEADERSHIP DEVELOPMENT AND POSITIVELY IMPACT THE HEALTH, SAFETY AND ECONOMIC SECURITY OF WOMEN AND GIRLS IN THE FOX VALLEY REGION. THIS IS A DECREASE IN THE NUMBER OF GRANTS AWARDED FROM THE PRIOR YEAR, AND A CONTINUATION OF OUR STRATEGIC DECISION TO AWARD FEWER, LARGER GRANTS. AVERAGE GRANT SIZE INCREASED BY 4.4% TO NEARLY \$2,245. GRANT MAKING INCLUDED A FIFTH YEAR OF OUR SUCCESSFUL GIRLS' GRANT MAKING PROJECT WHICH ENGAGES HIGH SCHOOL AGE GIRLS IN A LEADERSHIP AND PHILANTHROPY EDUCATION EXPERIENCE. WE ALSO CONTINUED OUR COMMUNITY EDUCATION EFFORTS BY HOLDING A PANEL DISCUSSION ABOUT HOMELESSNESS IN OUR COMMUNITY WHICH INCLUDED LOCAL NONPROFITS SERVING PRIMARILY FEMALES WHO ARE HOMELESS OR IN TRANSITIONAL HOUSING. THE PANEL ALSO INCLUDED THE HOMELESS EDUCATION SOCIAL WORKER FROM THE APPLETON AREA SCHOOL DISTRICT. WE LAUNCHED TWO NEW PHILANTHROPY EDUCATION PROGRAMS. IN MARCH WE HELD A PHILANTHROPY FORUM TO TEACH WOMEN HOW TO TALK TO THEIR FAMILIES AND FINANCIAL ADVISORS ABOUT THEIR CHARITABLE INTERESTS. IN JUNE WE OFFERED DO SOMETHING! DAY, A ONE-DAY PHILANTHROPY EDUCATION CAMP FOR MIDDLE AND HIGH SCHOOL STUDENTS.
