The President and Secretary (to the extent not a Director) shall serve as ex officio members of the Board of Directors. An Officer may resign at any time by delivering written notice to the Board. There is no longer a Treasurer. Executive Committee: The President may be designated by the Board of Directors as an ex officio member of the Executive Committee. The Board of Directors may accept on behalf of the Corporation any contribution, gift, bequest, or devise for the general purposes or for any special purpose of the Corporation, provided that it is in accordance with the Internal Revenue Code requirements for a public charity.
