In collaboration with our global partners, GGP directed significant resources to designing new products, applying current fashion trends to our partners traditional skill sets This included providing training in product design and prototype development GGP also explored and created new partnerships to meet the demands of our existing custom clients, devoting resources to researching, interviewing and visiting prospective artisan communities in Africa, Asia and Latin America We continued to partner with an organization in Guatemala that produces a collection of bracelets that GGP aggressively promotes through both retail and wholesale channels In addition to receiving a fair living wage, the artisans receive a range of household improvements and family health benefits including maternal and infant health care, smokeless stoves, water filters, solar cookers and organic garden kits
