

Its primary emphases are on preparing new faculty to teach in African universities and on upgrading the qualifications of current faculty. RISE networks provide comprehensive graduate training programs, where students and faculty seeking advanced degrees can take advantage of the COMPLEMENTARY instruction and research opportunities available at each institution within the network. Networks also enable researchers from multiple universities to use specialized scientific instrumentation that may be available at only one of the sites, or to pool resources to obtain new equipment. Selection criteria included scientific merit, training capacity, research activities, evidence of institutional support, added value of the network versus separate support to individual institutions, and potential for sustainability. An especially important criterion was a strategy for retaining at universities in the region faculty members who have received their training through RISE. Grantees are required to submit narrative and detailed financial reports twice yearly. The Institute for Advanced Study (the Institute) is one of the world's leading centers for theoretical research and intellectual inquiry. The Institute exists to encourage and support fundamental research in the sciences and humanities - the original, often speculative, thinking that produces advances in knowledge that change the way we understand the world. It provides for the mentoring of scholars by Faculty, and it offers all who work here the freedom to undertake research that will make significant contributions in any of the broad range of fields in the sciences and humanities studied at the Institute. The Institute is a private, independent academic institution located in Princeton, New Jersey. It was founded in 1930 by philanthropists Louis Bamberger and his sister Caroline Bamberger Fuld, and established through the vision of the founding Director Abraham Flexner. Past Faculty have included Albert Einstein, who remained at the Institute until his death in 1955, and distinguished scientists and scholars such as Kurt Godel, J. Robert Oppenheimer, Erwin Panofsky, Homer A. Thompson, John Von Neumann, George Kennan and Hermann Weyl.
