Scholarship and fellowship grants were awarded to New Jersey Institute of Technology in the amount of \$3,520,920. Foundation at New Jersey Institute of Technology receives endowed gifts and annual gifts restricted for financial aid. The annual endowment spending for scholarships and fellowships and the annual scholarship and fellowship gifts are granted to New Jersey Institute of Technology and awarded to students that have met the qualifications and restrictions placed by the donors. Undergraduate and graduate awards, from donor funded scholarships and fellowships were given to approximately 1,200 students.

Research and program grants totaling \$2,476,911 were awarded to New Jersey Institute of Technology to support various research projects, including a computer software gift-in-kind of \$2,177,400 (see Schedule B) and \$299,511 of restricted gifts for various New Jersey Institute of Technology programs.
