FOR FIVE DAYS, NEWARK'S BUSTLING ARTS SCENE EXPLODES WITH AN ARRAY OF EXHIBITS, TALK-BACKS, PERFORMANCES, STREET DISPLAYS, STUDIO OPEN HOUSES, AND MORE. THE CITYWIDE ARTS TOUR AND COMMUNITY EVENT CELEBRATES NEWARK'S UNIQUE AND DIVERSE CONTRIBUTIONS TO THE ARTS AND TO AMERICAN CULTURE.
