Site visits are performed on a random basis to ensure that the agency is in compliance with food storage requirements and to see that the food is being used appropriately. Additionally, all distributions are verified monthly to ensure that the purchases and distributions are appropriate for the type of agency operations. Agencies that do not meet the eligibility requirements or that do not stay in compliance will no longer be able to receive distributions or make purchases.
