THE MISSION OF LUCY’S HEARTH IS TO PROVIDE COMPREHENSIVE PROGRAMS AND SERVICES TO HOMELESS FAMILIES IN A SAFE, SUPPORTIVE ENVIRONMENT THAT PROMOTES FAMILY HEALTH AND STABILITY AND INCREASES SELF-SUFFICIENCY IN ORDER TO ACHIEVE PERMANENT AFFORDABLE HOUSING

RESIDENTS OF LUCY'S HEARTH'S EMERGENCY SHELTER, SUPPORTIVE HOUSING PROGRAM, AND TRANSITIONAL APARTMENTS PARTICIPATE IN CASE MANAGEMENT, PARENTING AND LIFE SKILLS, GED CERTIFICATE (HIGH SCHOOL EQUIVALENCY), AND FINANCIAL MANAGEMENT CLASSES, AS WELL AS RECEIVING REFERRALS TO OUTSIDE PROVIDERS FOR HIGHER EDUCATION, TRAINING, MEDICAL CARE, AND ADDITIONAL MENTAL HEALTH TREATMENT. RESIDENTS ARE REQUIRED TO PARTICIPATE IN SHELTER SERVICES DURING THE YEAR, 42 MOTHERS AND 84 CHILDREN RECEIVED SERVICES THROUGH LUCY'S HEARTH'S EMERGENCY SHELTER, SUPPORTIVE HOUSING PROGRAM AND TRANSITIONAL APARTMENTS FOR A TOTAL OF NEARLY 16,974 SHELTER AND TRANSITIONAL BED NIGHTS AND NEARLY 28,804 MEALS SERVED. THE TYPICAL LENGTH OF STAY FOR THE EMERGENCY SHELTER PROGRAM IS THREE TO SIX MONTHS WITH RESIDENTS STAYING IN THE SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENTS FOR UP TO TWO YEARS. FOR THE SUPPORTIVE HOUSING PROGRAM AND TRANSITIONAL APARTMENTS, LUCY'S HEARTH HAS APARTMENTS IN VARIOUS NEWPORT COUNTY LOCATIONS. THE PROGRAM ASSISTS MOTHERS AND THEIR CHILDREN TO OVERCOME BARRIERS TO LIVING ON THEIR OWN WITH AN EMPHASIS ON SELF-SUFFICIENCY. TO BE ELIGIBLE FOR THIS PROGRAM, MOTHERS MUST HAVE SUCCESSFULLY COMPLETED THE EMERGENCY SHELTER PROGRAM, AND BE WORKING OR GOING TO SCHOOL. PROGRAM PARTICIPANTS CONTINUE TO PARTICIPATE IN LIFE SKILLS EDUCATION AS WELL AS CASE MANAGEMENT IN THEIR APARTMENT ON A WEEKLY BASIS. IF NEEDED, MOTHERS AND THEIR CHILDREN MAY STILL RETURN TO THE EMERGENCY SHELTER PROGRAM TO PARTICIPATE IN PROGRAMS AND SERVICES. LUCY'S HEARTH HAS A COMMITMENT TO ENSURING ITS RESIDENTS AVOID FUTURE HOMELESSNESS. FORMER RESIDENTS OF ANY LUCY'S HEARTH PROGRAM MAY RECEIVE CASE MANAGEMENT, CRISIS INTERVENTION, BUDGETING ASSISTANCE, REFERRALS TO COMMUNITY PROVIDERS, AND ADVOCACY TO ASSIST IN ACCESSING COMMUNITY RESOURCES OR TO TROUBLE-SHOOT ISSUES THAT MAY ARISE IN 2014, LUCY'S HEARTH WAS ACCREDITED BY THE COUNCIL ON ACCREDITATION IN AUGUST 2015, LUCY'S HEARTH PURCHASED THE PROPERTY LOCATED AT 19 VALLEY ROAD, MIDDLETOWN, RHODE ISLAND, AND IS CURRENTLY RENOVATING THE PROPERTY INTO 16 EFFICIENCY APARTMENTS, ADMINISTRATIVE OFFICES AND COMMON SPACES. WE ARE PLANNING TO MOVE ALL SHELTER AND ADMINISTRATIVE OPERATIONS FROM OUR CURRENT LEASED LOCATION INTO THE NEWLY RENOVATED LOCATION IN FALL OF 2016.
