HUMAN SERVICE EXPENSE THE TWO TEN MISSION IS TO BRING SHOE PEOPLE TOGETHER TO HELP EACH OTHER DURING CRISIS, SUPPORT EACH OTHER AS A COMMUNITY, AND ENSURE THE FUTURE OF THE FOOTWEAR INDUSTRY IN THE UNITED STATES IN FY16, THE TWO TEN SOCIAL SERVICES TEAM ASSISTED 1,234 FOOTWEAR FAMILIES WITH EMERGENCY ASSISTANCE TWO TEN RECEIVED CALLS FROM A TOTAL OF 2,735 FOOTWEAR WORKERS AND THEIR FAMILIES AND 99% OF THOSE WORKERS RECEIVED A CALL BACK WITHIN TWO BUSINESS DAYS TO COMPLETE OUR INTAKE PROCESS THE 30 MINUTE INTAKE CALL IS THE WAY WE DETERMINE ELIGIBILITY AND HOW BEST TO MEET IMMEDIATE NEEDS WHEN A PERSON CALLS TWO TEN, WE GUARANTEE THEY WILL QUICKLY SPEAK WITH A COMPASSIONATE INDIVIDUAL AND THEIR CONVERSATION WILL BE CONFIDENTIAL IN FY16, 72% OF CALLERS WERE FEMALE AND 28% OF CALLERS WERE MALE THE THREE LARGEST AGE GROUPS WHO CALLED WERE BETWEEN THE AGES OF 25-34 (33%), BETWEEN THE AGES OF 43-55 (25%), AND 22% OF CALLERS FELL BETWEEN THE AGES OF 35-42 THE POPULATIONS OF FAMILIES WE SERVE ARE EMPLOYED PREDOMINATELY IN THE FOLLOWING ROLES WITHIN THE FOOTWEAR INDUSTRY RETAIL SALES, CUSTOMER SERVICE, FACTORY WORKERS, WAREHOUSE OPERATIVES, AND DISTRIBUTION WORKERS THESE JOBS ARE LOW WAGE EARNING POSITIONS AND THOSE WORKING IN THEM ARE VULNERABLE TO LOSS OF INCOME AT DIFFERENT TIMES OF THE YEAR WHEN BUSINESS SLOWS OR ORDERS IN A FACTORY OR WAREHOUSE DECREASE TWO TEN CHANGES THE LIVES OF INDIVIDUALS AND FAMILIES DURING TIMES OF IMMEDIATE CRISIS BY PROVIDING THE FOLLOWING SERVICES TO HELP THEM EMERGENCY ASSISTANCE, HOUSING, UTILITIES, CAR REPAIRS, NATURAL DISASTER RELIEF, COUNSELING AND INFORMATION REFERRALS IN FY16, TWO TEN PROVIDED FUNDS TO PAY THE RENT OR MORTGAGE OF 663 FAMILIES TO PREVENT EVICTION OR FORECLOSURE WE ASSISTED 582 FAMILIES WITH EMERGENCY UTILITY SUPPORT AND CAR PAYMENTS OR CAR REPAIRS FOR 451 FAMILIES SO THEY COULD CONTINUE TO USE THEIR CAR TO GET TO WORK TWO TEN ALSO HELPED WITH 125 CRISIS CASES WHICH INCLUDES \$3,000 IN FUNERAL BILLS AND EMERGENCY COSTS WHEN AN INDIVIDUAL WAS DISPLACED DUE TO A FIRE, FLOOD AND NATURAL OR COMMUNITY DISASTER FUNDS ARE PAID DIRECTLY TO THE CREDITORS EXCEPT IN A SMALL NUMBER OF CASES WHEN MINI-GRANTS BETWEEN \$50-\$500 ARE GIVEN TO THOSE INDIVIDUALS IN CRISIS WHO ARE DOCUMENTED TO HAVE BEEN DISPLACED OR IMPACTED BY SAID DISASTER THE MONIES THAT ARE GIVEN HELP INDIVIDUALS GET THROUGH THEIR CRISIS BEHAVIORAL HEALTH TO ADMINISTER 8 SESSIONS OF TELEPHONIC COUNSELING SERVICES PER CALLER REFERRALS TO LOCAL COMMUNITY RESOURCES, SUCH AS UNITED WAY, RED CROSS AND SALVATION ARMY WERE GIVEN TO 783 INDIVIDUALS THE REASON MOST CITED BY THOSE NEEDING ASSISTANCE WAS "EMPLOYMENT ISSUES", FOLLOWED BY "HEALTH AND "FAMILY ISSUES " TWO TEN PROVIDES RESOURCES FOR SHOEPEOPLE FROM 47 STATES ACROSS THE COUNTRY AS WELL AS PUERTO RICO, BUT THE TOP FIVE STATES THAT WE RECEIVED CALLS FROM WERE TENNESSEE, MICHIGAN, INDIANA, CALIFORNIA AND KENTUCKY EDUCATION EXPENSES PART OF OUR COMMITMENT TO STRENGTHENING THE FOOTWEAR INDUSTRY, TWO TEN FOOTWEAR FOUNDATION OFFERS FOOTWEAR EMPLOYEES AND THEIR FAMILIES HIGHER EDUCATION SCHOLARSHIPS BASED ON FINANCIAL NEED, ACADEMIC ABILITY AND PERSONAL PROMISE IN FY16, TWO TEN FUNDED 310 STUDENTS WITH SCHOLARSHIPS IN COLLEGE TUITION 83% OF THE STUDENTS ARE ATTENDING TWO-YEAR AND FOUR-YEAR PUBLIC UNDERGRADUATE UNIVERSITIES AND COLLEGES ACROSS THE COUNTRY, WHILE 17% ARE ATTENDING PRIVATE SCHOOLS SCHOLARSHIP FUNDS WERE AWARDED TO 168 RENEWAL SCHOLARS AND 142 NEW SCHOLARS MOST STUDENTS RECEIVED AN AWARD BETWEEN \$2,500 AND \$5,000 WITH THE OPPORTUNITY TO RENEW ANNUALLY, PROVIDED THAT THEY MAINTAIN A REQUIRED GPA OF AT LEAST 2.5 AS OF JULY 2015, ALL NEW SCHOLARSHIP AWARDS WILL AVERAGE \$3,000 PER ANNUM, RENEWABLE FOR THREE YEARS TWO TEN ALSO PROVIDES A SCHOLARSHIP FOR MILITARY VETERANS, CALLED THE FOOTWEAR WARRIORS ENDOWED SCHOLARSHIP THIS SCHOLARSHIP IS MADE AVAILABLE TO THE MEN AND WOMEN WHO HAVE SERVED OUR U.S. MILITARY AND ARE CURRENTLY WORKING IN THE FOOTWEAR INDUSTRY WITH THE COST OF HIGHER EDUCATION SOARING, TWO TEN SCHOLARSHIPS HELP EASE THE BURDEN FOR THOSE FOOTWEAR FAMILIES SENDING THEIR CHILDREN TO COLLEGE TO BE ELIGIBLE TO APPLY AND BE CONSIDERED FOR A TWO TEN SCHOLARSHIP, THE APPLICANT MUST BE WORKING WITHIN THE FOOTWEAR INDUSTRY FOR A MINIMUM OF TWO YEARS, OR THE CHILD OF A PARENT WORKING IN THE INDUSTRY FOR THE SAME DURATION THE SCHOLARS WORKING IN THE FOOTWEAR INDUSTRY COMPRISED 27% OF THE TOTAL POOL, WHILE THE REMAINING 73% HAD PARENTS WORKING IN THE FOOTWEAR INDUSTRY AS A NOTE, 49% OF SCHOLARS' FAMILIES COULD NOT CONTRIBUTE ANYTHING TO THEIR CHILD'S EDUCATION EXPENSES TWO TEN ALSO OFFERS A SPECIALTY SCHOLARSHIP FOR THOSE PURSUING EDUCATION IN THE AREA OF FOOTWEAR DESIGN, THE FOOTWEAR DESIGN SCHOLARSHIP IS AVAILABLE TO ANY STUDENT WITHOUT EMPLOYMENT HISTORY IN THE FOOTWEAR INDUSTRY THIS SCHOLARSHIP WAS CREATED TO ENCOURAGE STUDENTS ENTERING THE FIELD WHO HAVE TALENT AND PROMISE IN FOOTWEAR DESIGN APPLICANTS FOR THE FOOTWEAR DESIGN SCHOLARSHIP ARE REQUIRED TO SUBMIT THREE SAMPLES OF THEIR SKETCHES AT THE TIME OF APPLICATION IN ADDITIONAL TO COMPLETING OUR STANDARD ONLINE APPLICATION THE APPLICATION ADMINISTRATION PROCESS IS OUTSOURCED TO THE INTERNATIONAL SCHOLARSHIP AND TUITION SERVICES (ISTS) AFTER ISTS PRESENTS THE COMPLETED APPLICATIONS, TWO TEN SCHOLARSHIP STAFF RANKS APPLICANTS USING A SCORING RUBRIC THAT IS WEIGHED BY THE FOLLOWING SYSTEM 70% FINANCIAL NEED, 15% ACADEMICS BASED ON GPA AND 15% ACADEMIC RESUME BASED ON EXTRACURRICULAR ACTIVITIES TWO TEN THEN
