THE ANNUAL FUND OF THE SUMMIT EDUCATION FOUNDATION ENCOURAGES AND FUNDS TEACHER AND DISTRICT-INITIATED PROGRAMS THAT ADVANCE THE CURRICULUM AND DISTRICT OBJECTIVES. DURING THE 2015-16 FISCAL YEAR, 49 GRANTS TOTALING \$196,949 WERE AWARDED FROM THE ANNUAL FUND. THE LARGEST GRANT AWARDS FUNDED THE FOLLOWING INITIATIVES: HISPANIC AND ELL ACADEMIC OUTREACH COORDINATOR - \$130,000. THIS GRANT REQUEST IS TO FUND THE POSITION OF AN HISPANIC AND ELL ACADEMIC OUTREACH COORDINATOR WITHIN THE DISTRICT. THE POSITION'S EXISTENCE IS CRITICAL TO HELP ELL (ENGLISH LANGUAGE LEARNERS) STUDENTS FACE THE BARRIERS ENCOUNTERED WHEN THEY TRANSITION INTO THE PUBLIC SCHOOLS. THE POSITION WILL COORDINATE ALL RESOURCES TO OFFER THE BEST POSSIBLE EXPERIENCE TO ELL STUDENTS AND THEIR FAMILIES. PROJECT ADVENTURE GRANT - \$17,000. PURCHASE A SECOND MULTI SWING (INDOOR) AND INSTALL THE STATIONARY INITIATIVE WALL (OUTDOOR) WHICH WILL ADD 2 NEW ADVENTURE CHALLENGES TO THE EXISTING PROJECT ADVENTURE CURRICULUM. PEER LEADERSHIP PROGRAM (PCP) - \$10,005. FUNDS WILL BE USED FOR STAFF STIPENDS AND TRAINING OF 30-35 PEER LEADERS (PL). IN YEAR ONE, 30 JUNIORS AND SENIORS WILL SERVE AS PL'S AND ROLE MODELS FOR ELEMENTARY, MIDDLE, AND HIGH SCHOOL STUDENTS ACROSS THE DISTRICT. PL STUDENTS WILL BE SUBJECTED TO A COMPETITIVE APPLICATION PROCESS AND RIGOROUS LEADERSHIP TRAINING. PEER LEADERS WOULD BE THE FACILITATORS OF CHARACTER DEVELOPMENT PROGRAMS AT ELEMENTARY SCHOOLS, TRANSITION WORKSHOPS AT THE MIDDLE SCHOOL, AND STUDENT RUN PROGRAMS IN HEALTH CLASSES AND MENTORSHIP GROUPS FOR NEW STUDENTS AT THE HIGH SCHOOL. 21ST CENTURY CLASSROOM - \$9,315. PURCHASE ONE HISTORY CLASSROOM OF MOBILE DESKS WITH INTEGRATED CHAIRS WHICH MOVE ON CASTERS FOR EASY MOVEMENT. THESE ALLOW QUICK AND EASY MOVEMENT INTO A VARIETY OF DIFFERENT GROUPINGS TO FACILITATE GROUP DISCUSSIONS. THE TEACHER IS MOST INTERESTED IN PROMOTING THE HARKNESS DISCUSSION METHOD OF TEACHING.

THE ENDOWMENT FUND OF THE SUMMIT EDUCATIONAL FOUNDATION PROVIDES FUNDING FOR STRATEGIC LONG-TERM INITIATIVES CRITICAL TO THE HEALTH OF THE DISTRICT AND ITS ABILITY TO PROVIDE AN EXCELLENT EDUCATIONAL EXPERIENCE FOR ITS STUDENTS. THE ENDOWMENT FUND WAS CREATED AS A WAY TO ENSURE FUTURE FUNDING TO DEVELOP NEW CURRICULUM INITIATIVES AND PROVIDE PROFESSIONAL DEVELOPMENT TO MEET THE NEEDS OF 21ST CENTURY LEARNERS. DURING THE FISCAL YEAR ENDED JUNE 30, 2016, GRANTS AWARDED TOTALED \$58,237. FUNDED GRANT ACTIVITIES INCLUDE STEAM CARNIVAL - \$5,950. THIS WILL BE A ONE-DAY EVENT FOR GRADES K-5 FROM 10AM-2PM HELD AT BRAYTON SCHOOL ON OCTOBER 15, 2016. WE PLANNED AND EXECUTED THIS ONE-DAY EVENT IN THE FALL OF 2015 AND HAD OVER 300 PARENTS AND STUDENTS ATTEND. WE ARE LOOKING TO CONTINUE THIS ANNUALLY DUE TO THE SUCCESS OF THE PROGRAM. SAMPLE ACTIVITIES THAT WERE IMPLEMENTED BY OUR STAFF AND FACULTY INCLUDED, BUT WERE NOT LIMITED TO: GIANT JENGA, MAKE A MODEL OF A ROLLERCOASTER, EXPLORE CHEMICALS, SPIN ART, ENGINEERING WITH LEGOS, STAR LAB PLANETARIUM, THE SCIENCE OF MUSIC, ENGINEERING INSPIRED BY NATURE, CODING, ORIGAMI, 3-D PRINTER DEMONSTRATIONS, SPAGHETTI TOWER, AND PRESENTATIONS BY LIBERTY SCIENCE CENTER AND PLAYWELL. ONLINE LEARNING THROUGH VIRTUAL HIGH SCHOOL - \$52,287. THIS TWO-YEAR GRANT WILL ALLOW SUMMIT HIGH SCHOOL TO EXPAND ITS COURSE OFFERINGS FOR STUDENTS IN GRADES TEN, ELEVEN, AND TWELVE THROUGH THE IMPLEMENTATION OF VIRTUAL HIGH SCHOOL COURSES. THE HIGH SCHOOL ADMINISTRATION, IN CONJUNCTION WITH SUPERVISORS, WILL SELECT COURSES FROM THIS LIST TO OFFER STUDENTS DURING THE 2016-2017 SCHOOL YEAR. THIS GRANT ALSO INCLUDES PAYROLL FOR A STAFF MEMBER AS VIRTUAL HIGH SCHOOL INSTRUCTOR.
