Decisions regarding compensation were handled by the executive committee at the time of hire. The annual salary was based on what the board felt was affordable for the organization at the time of hire. It was understood that the salary offered was lower than the industry standard. The hiring decision was approved by the board of directors at that time, which approves the annual budget that also shows compensation of the Executive Director each year. Staff salaries for program staff are on the low end of the industry standard. The Board decided not to increase salaries until it believes the organization will have the resources to do so.
