Part I, Line 2	CPS Scholarships Through the ATWD grant, NJPN provides scholarships to Certified Prevention Specialist students attending approved CPS classes offered at two prevention agencies in the state. Students must submit an application for review and must meet specific criteria set by NJDMHAS for approval. NJPN provides scholarship vouchers to the students to attend the approved classes. Each month the host agencies invoice NJPN for reimbursement for the scholarship students that successfully complete the course and receives the agreed upon amount per student plus a small administrative fee. Online CADC Scholarships Through the ATWD grant, NJPN permits a limited number of students (based on the budgeted amount) in need of five or less courses to graduate to take their remaining courses through a web-based program. NJPN registers the students using the online course service provider program, which generates a user name and password to log on and take the course. NJPN receives a weekly report from the online course provider indicating which students successfully completed the course requirements within that specific week so NJPN may track student progress and number of scholarships distributed. Each month the online course provider invoices NJPN for reimbursement and receives the agreed upon amount per student plus an administrative fee. NJPN Annual Conference Registration NJPN provided complimentary event registrations for staff members of The Department of Human Services. Conference scholarships are non-cash, providing little opportunity for the misuse of funds. Peer Recovery Specialist Certification Course Registration Through the ATWD grant, NJPN provided scholarships for the CCAR Peer Recovery 7-day training through NCADD-NJ and the OORP 3-day Peer Ethics training series provided by NJPN for OORP workers pursuing Peer Recovery Specialist Certification from 3 DMHAS agencies (Barnabas Health, Eva's Village, and the Center for Family Services). Ethics training was offered in two rounds of the 3 day training and CCAR was offered in one round which was 7 consecutive days. NJPN worked with 3 coordinators from each DMHAS Grantee agency to confirm attendance of their respective OORP workers. Upon successful completion of all course requirements, each agency invoiced for the Ethics and/or CCAR scholarship per OORP worker and per course.

Form 990, Part III, Line 4a, Program Service Accomplishments	Annual Addiction Conference NJPN's 16th Annual Addiction Conference was held this year and brought over 1,100 professionals together for the state's premier event focused on substance abuse prevention, early intervention, treatment and recovery support. The Conference facilitates the dialog between leaders at the local, county and state level in order to better serve New Jersey's communities. The focus is on educating the state's front-line professionals about critical issues surrounding substance abuse and providing a unique forum for networking, collaboration and workforce development. Educational sessions taught by national and state experts provide attendees with the latest research and information pertinent to their respective fields. This venue provides an opportunity for the addiction community to come together to learn more about their specific area of focus, as well as other topics and issues that will help to create a stronger continuum of care in New Jersey. NJ Highway Traffic Safety A special educational track was created for NJPN's Annual Addiction Conference that was funded through the Division of Highway Traffic Safety Department. This track targeted preventionists and offered a power session and two workshops that made the connection between drug and alcohol use by youth and the high risk of drinking and drugged driving. Addictions Training and Workforce Development (ATWD) Project This workforce development project provides the required 270 hours of education needed for individuals who are interested in becoming licensed or certified alcohol and drug counselors. The full curriculum of courses is provided at eight sites throughout the state, free of charge to participants. Advanced training is also provided for CADAC and LCADC professionals. Scholarships for free classes for those interested in becoming a Certified Prevention Specialist(CPS) are also offered through NJPN and other approved providers throughout the state. Military Personnel and their Families NJPN coordinates this statewide project through a network of local prevention partners that provide prevention programs to military personnel and their families. Military personnel and their families are facing many challenges that can significantly impact their lives. Often, these challenges trigger stressors that can lead to family dysfunction, substance abuse, and other negative outcomes. NJPN developed two evidence-based programs to help support the New Jersey military community. These programs build on the strengths of these inspiring individuals and families and provide an opportunity to focus on family and life balance through parental and youth skill building, improved family communication and healthy coping skills to reduce stress. Military Family Nights and Achieving Personal Balance offer a prevention intervention that can strengthen the military community. Training and Technical Assistance for the State's 17 Regional Substance Abuse Prevention Coalitions The New Jersey Division of Mental Health and Addiction Services created a network of Regional Coalitions to address the state's substance abuse prevention priorities. NJPN was selected to provide technical assistance and support to the 17 Regional Coalitions regarding implementing the Strategic Prevention Framework including needs assessment, capacity building, planning, and implementation. Guided by national research as well as its own experiences, NJPN facilitates, participates in and provides technical assistance and support to the 17 coalitions. NJPN works with each regional coalition to successfully assess data, determine consumption patterns and consequences, prioritize needs, and develop a comprehensive strategic plan and logic model specific to their region and based upon relevant topics as guided by the four state-identified priorities. Through trainings, webinars and one-on-one technical assistance, NJPN is supporting the effective implementation of environmental strategies that will make population-level change within New Jersey. Tobacco Free for a Healthy NJ NJPN coordinates the Tobacco Free for a Healthy NJ (TFHINJ) statewide project focusing on increasing the residents' access to smoke-free air where they work, live, and play. NJPN receives funding from the New Jersey Department of Health, Office of Tobacco Control, Nutrition and Fitness to provide regional outreach efforts in partnership with Atlantic Prevention Resources and the Center for Prevention and Counseling. The TFHINJ Program works to reduce tobacco use and the negative impact of secondhand smoke in all counties of New Jersey. This project promotes opportunities for smoke-free living by providing training and technical assistance to housing authorities, property managers, and landlords who want to transition their multi-unit housing complexes to smoke-free housing. The program also provides business owners with help improving or creating new. Worksite Wellness initiatives to support cessation and reduce tobacco use among the workforce. In addition, NJPN staff provides technical assistance to municipalities to create smoke-free outdoor ordinances as well as to reduce youth access to cigarettes, e-cigarettes and hookah by implementing point-of-sale strategies in establishments that sell these products. This multi-strategy program also includes a media campaign to encourage smoke-free living and promote the use of NJ Quitline and other tobacco cessation resources. The project also creates synergistic opportunities to engage local coalitions and public health advocates to promote tobacco control initiatives in their prevention work. Evaluation Support for the Regional Coalitions NJPN has been contracted by Rutgers to assist them in providing evaluation support to the 17 Regional Coalitions. The Evaluation Team has created consistent data collection tools that the Regional Coalitions have utilized during their needs assessment process to capture statewide information on the substance abuse trends, policy scan details and prevention resources. As this project moves forward, a comprehensive evaluation plan will be developed and implemented to measure the successes of the Regional Coalition Project. NJ Drug Free Communities (Impact NJ) In September 2014, the IMPACT NJ Coalition received a Drug-free Communities grant from the Office of National Drug Control Policy (ONDCP). It is one of only two statewide grants of this kind in the country. The IMPACT NJ Coalition focuses on reducing alcohol and marijuana use among youth 18 and under throughout the State of New Jersey. Building from current and previous coalitions coordinated by NJPN, IMPACT NJ brings together state and local leaders who are dedicated to sharing their expertise and time and work collaboratively to achieve common goals. The mission of the IMPACT NJ Coalition is to reduce substance use and abuse among youth through strong collaboration with key stakeholders, building capacity among members based on best practices, implementing evidence-based environmental strategies, and advocating for positive community changes. Be The One Mobile Application The Rutgers School of Social Work asked NJPN to collaborate with them to create a mobile app to support the efforts of the Regional Substance Abuse Prevention Coalitions. The result of this collaboration is Be The One, designed to invite users to share their view and take action. Be The One empowers people throughout New Jersey to make a difference in their county, by capturing and reporting the good and bad that impacts communities as it relates to substance abuse and youth. The app is a tool to post photos displaying a view of the community which will help local prevention coalitions focused on creating healthier communities in the county. It encourages everyone to "Be The One" to make a difference. The app also connects users to resources and tools to help themselves, a friend, or a family member that is in trouble with drugs or alcohol. Get Active NJ Program NJPN's Get Active NJ program is funded by the NJ Department of Health and provides technical assistance, training and incentives to assist municipalities to find ways to educate stakeholders on different policies that can help promote walking and the many benefits that this can have on their communities. In order to help accomplish this, NJPN offers financial assistance to a small number of communities to help them evaluate and educate stakeholders on potential policy changes. In addition to financial resources, NJPN provides technical assistance and trainings to municipalities as they move through the policy change process in order to help them navigate its complexities.
