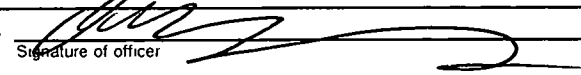

Full Members are initially approved by the Personnel/HR Committee to a six month introductory period after which members are then presetned to the general membership for a majority vote of approval to full membershji in the Organization. Full Members have voting rights.

Associate Members assist with fudn raising, administrative and other tasks and do not have voting rights.

Voting members elect Executive Officers (two year terms) and certain committee positions. All other committee positions are appointed by the (4) Executive Officers and approved by the general membership.
