NJCSA also provides new charter applicant support and technical supports to newly opened schools. We depend on foundation support, member dues and fee for service revenue to support our school services work.

New Jersey Charter Schools Conference The NJ Charter Public Schools Conference was a two-day event that offered professional development breakout sessions, an exhibit hall, dynamic keynote speakers, student performances and face-to-face networking opportunities to charter school leaders, administrators, trustees, educators, parents, supporters, business affiliates, legislators and partners. The conference relies on financial support from event participants and outside donors.

Advocacy NJCSA provides public policy, advocacy, and community education and outreach services for New Jersey's charter school sector, which includes providing leadership training to community stakeholders, and organizing activities and support for charter schools throughout the state. NJCSA develops charter policy informed by data and input from its Members Council, and is augmenting its public policy work with a strong community outreach effort to engage the public in informed discussion of charter schools, one of the primary education reform issues in New Jersey. We depend on foundation support and annual advocacy contributions from our member schools to support out advocacy efforts.
