Part VI - Needs Assessment	As noted, WellSpan-Ephrata Community Hospital conducted two Community Health Needs Assessments (CHNA) during this tax year. The first, a county-wide CHNA, was conducted in partnership with the Lancaster Health Improvement Partnership (LHIP) and its partner organizations using the Conduent-Healthy Communities Initiative model. These entities regularly collect available secondary data on diverse topics including community demographics, health behaviors and conditions, vital statistics, and, community conditions (i.e., air and water quality), and share it with community members through its organizational websites. The current county-wide CHNA may be found on the WellSpan Health website (www.wellspan.org). In addition, results are annually shared at the Lancaster Health Summit, a partnership between LHIP and the Lancaster County Business Group of Health. After its affiliation with WellSpan Health, a regional health care system, WellSpan-Ephrata Community Hospital (WECH) engaged in the next iteration of the system-wide CHNA process. This process, refined after being conducted in York and Adams counties for 20 years, enabled WECH to obtain data about its primary market, share it with key community, hospital and system leaders, and integrate it into the system-wide and entity-level planning processes. Through the consulting support of the Floyd Institute for Public Policy at Franklin and Marshall College, a representative sample of 729 adults residents in the greater Ephrata (Northern Lancaster County) area were interviewed between February 23 and May 5, 2015 using survey questions derived from the Behavioral Risk Factor Surveillance System (BRFSS), a validated survey tool utilized by the Centers for Disease Control and Prevention (CDC), and organized into four categories: healthcare access, behavioral risk, health conditions, and prevention behaviors and context. Supplemental secondary data from the Robert Wood Johnson Foundation (RWJF) annual County Health Rankings and from the Pennsylvania Department of Health was compiled and integrated into the 2015 CHNA. Data collected and analyzed by the Floyd Institute for Public Policy included breakdowns by age, gender, geographic area, race/ethnicity, and income level, and enabled the development of charts/graphs focused on quantity of residents affected, health risks and disability-adjusted life years, correlates of obesity and depression (two significant health priorities), health disparities, and, social determinants of health impact. This information is included in the 2015 Community Health Needs Assessment Summary Report available at www.wellspan.org. In 2015, CHNA results and related priorities identified by WellSpan-Ephrata Community Hospital and its community partners were shared with the system-wide Planning Committee at WellSpan Health. This Committee is comprised of community members and leaders that represent each of WellSpans primary entities and service areas, in addition to corporate leadership. Planning Committee members reviewed the CHNA data, adopted WECHs community priorities of adult overweight/obesity, and depression/mental health while also identifying two additional priorities: access related to gaps in care caused by high-deductible insurance plans and the emerging opioid misuse and abuse issue facing the community. These priorities and associated data were subsequently presented to the WellSpan-Ephrata Community Hospital Board for their adoption. CHNA results were made available to the public on the WellSpan Health (www.wellspan.org) website, and may also be obtained upon request.

Part VI - Explanation Of How Organization Furthers Its Exempt Purpose	Through its various locations in the greater Ephrata community, WellSpan-Ephrata Community Hospital provides a range of wellness and health education programs designed to address key CHNA findings and to promote healthy lifestyles and disease prevention. These programs include health screenings, diabetes education, nutrition and weight management counseling, tobacco cessation, CPR and first aid instruction, support groups, immunizations, community health fair participation, and, health education through newsletters and local television media. Many of these programs are offered for free or at a minimal cost to the participant. One example of a unique community-based partnership in which WellSpan-Ephrata Community Hospital continues to engage local children is implementation of the GO Ephrata¹ summer physical activity program. Through a partnership with the Ephrata Public Library and its Summer Reading Club, WellSpan-Ephrata Community Hospital annually encourages children and their families to be physically active during the summer months by participating in an adaptation of letterboxing, an international hobby where participants use written clues to find items hidden in various places. During fiscal year 2016, 1,228 children participated in the GO Ephrata¹ program, and 500 participants submitted their program rubbing sheets and collectively walked a total of 1,725 miles. Another iteration of the GO Ephrata¹ Program is planned for summer 2016. WellSpan-Ephrata Community Hospital served as a resource for students considering a healthcare career as well as those enrolled in healthcare training programs. Job shadowing opportunities and clinical training placements were available within hospital departments. In addition, the Ephrata Community Health Foundation assisted in raising funds to support community health and clinical initiatives of WellSpan-Ephrata Community Hospital. One significant initiative that was established during this fiscal year was the Cancer Help Fund, which assists patients in need and their families with short-term living expenses while undergoing long and difficult treatments. Additionally, WellSpan-Ephrata Community Hospital participated in system-wide initiatives to address the shared community health priorities of depression (mental health), advanced care planning, and adult overweight/obesity. The Feeling Blue depression awareness campaign (www.feeling-blue.com) originated as a resource for York and Adams County adults suffering from mild depression. In 2015, Feeling Blue expanded to the Ephrata area and continues to be a valuable resource to community members. WellSpan-Ephrata Community Hospital was also a partner with the county-wide Lets Talk Lancaster mental health initiative and collaborated to enhance collaborations among health care providers, consumers, families, and caregivers, reduce the stigma related to mental illness, and, improve consumer access to prevention, screening, treatment and recovery services. WellSpan-Ephrata Community Hospital also supported the education of greater Ephrata area residents about end-of-life planning and care, or Horizon Planning as it is termed locally, and the implementation of the regional 10Lb Throwdown initiative, a 10-week community challenge that encourages participants to lose or maintain a healthy weight through healthier eating and increased physical activity. The initiative was created to address the growing issue of adult overweight/obesity, and utilizes a core website (www.10poundthrowdown.com) on which may be found an online weight tracker, physical activity program (Make the Most of the Coast), and tips that promote a healthier lifestyle. More than 1900 community members across three southcentral Pennsylvania counties Adams, Lancaster, Lebanon, and York participated in the 2016 iteration of the 10Lb Throwdown program. Additional examples of how WellSpan-Ephrata Community Hospital fulfilled its community mission in the greater Ephrata (Northern Lancaster County) area may be found in the 2016 WellSpan Community Benefit Report available online at www.wellspan.org.
