Children and Youth Services To provide care and shelter for needy and neglected infants, children and teens by operating residential facilities. Christ's Home served 131 children in the residential facilities in the past year. For this purpose, 43 volunteers donated 823 hours during the course of the year to benefit the children and youth services program. In addition, Christ's Home supported two international children's ministries by providing grants to these organizations. These international ministries served 265 children through Christ's Home's support.

To provide for senior adults, by operating a continuing care retirement community offering independent living, personal care and skilled nursing services. Christ's Home served 565 seniors this past year. For this purpose, 45 volunteers donated 2843 hours during the course of the year to benefit senior programs. Day services within Memory Care were initiated this year.
