Mental Health and Medical Services - APM maintains two behavioral health clinics that deliver a spectrum of bilingual and culturally sensitive treatment and prevention services to more than 2,000 Philadelphia residents without geographic restriction. APM provides supporting housing programs to provide long-term help to the Hispanic homeless population by providing housing assistance and appropriate supportive services that help clients master the tools necessary for successful independent living

APM's Human Services division is composed of two main areas. Children, Youth and Family programs which provide services to children in their own homes, recruits foster parents, and offers adoption services, and the Improving Outcomes for Children (IOC) program, which is responsible for coordinating, integrating, and managing all child protective and child abuse and neglect prevention services in a designated geographic area in the city of Philadelphia. The program is also responsible for meeting the outcomes and performance standards related to these services, and ensuring that subcontractors are licensed and complete any training required by the Philadelphia Department of Human Services or the Pennsylvania Department of Human Services for the services they are providing
