THE SAFE OPTIONS PROJECT OF A WOMAN'S PLACE (AWP) SERVES VICTIMS OF DOMESTIC VIOLENCE AND THEIR CHILDREN BY PROVIDING THE OPPORTUNITY TO MAKE INFORMED DECISIONS THAT ENABLE THEM LIVE LIVES FREE OF DOMESTIC VIOLENCE. GROUP AND INDIVIDUAL COUNSELING, 24-HOUR HOTLINE, SHELTER, LEGAL ADVOCACY AND ASSISTANCE, AND FIRST RESPONSE SERVICES ARE AVAILABLE THROUGH THE PROJECT. DURING FY 2015-2016, AWP SHELTERED 96 WOMEN AND THEIR CHILDREN AND PROVIDED 5,872 HOURS OF SAFE SHELTER. ADDITIONALLY AWP PROVIDED 13,841 HOURS OF COUNSELING FOR ADULT VICTIMS AND 1,919 HOURS FOR CHILDREN. LEGAL ADVOCACY AND FIRST RESPONSE TEAMS ASSISTED 932 LEGAL CLIENTS BY PROVIDING COURT ACCOMPANIMENT DURING PROTECTION FROM ABUSE HEARINGS AND CRIMINAL TRIALS. THEY ALSO TRAINED PARTNER AGENCIES IN THE AREAS OF FAMILY LAW, DIVORCE, IMMIGRATION, AND CHILD/SPOUSAL ABUSE. OUR ATTORNEY AND PARALEGAL PROVIDED CIVIL LEGAL REPRESENTATION TO 90 CLIENTS PRO BONO.

THE PREVENTION PROJECT OF A WOMAN'S PLACE (AWP) BUILDS THE COMMUNITY'S ABILITY TO BREAK THE CYCLE OF VIOLENCE BY HELPING INDIVIDUALS, FAMILIES, ORGANIZATIONS, AND GROUPS UNDERSTAND THE ISSUE OF DOMESTIC VIOLENCE AND HOW THEY CAN BE PART OF THE SOLUTION.
