 Fall 2015 Carmina Burana & Swan Lake Act II - a mixed repertoire, semi-professional ballet - 4 performances  
 Our Fall Series 2015 featured two premieres. Resident Choreographer Nancy Page's, Carmina Burana & Philadelphia-based Choreographer Meredith Rainey's Swan Lake Act II. A third piece on the mixed bill showcased some of the younger members of the company and was titled "Now We Are Free", another work by Ms. Page. Carmina Burana was performed in collaboration with a local choral group, The Brandywine Singers. The ability to have live music and live dance on the same stage was an incredibly powerful experience for both groups of artists and the audiences. Rainey's Swan Lake Act II was based off of the original choreography by Marius Petipa, and used the iconic score by Tchaikovsky. Mr. Rainey's new twist on an old classic was a challenge for our dancers and a treat for our audiences. This mixed repertoire production allowed our audiences to experience both Classical and Contemporary Ballet.

 Winter 2015 The Nutcracker - a full-length semi-professional ballet - 8 performances  
 The Nutcracker is a beloved Holiday Tradition that spans global audiences. We are proud to present a professionally staged production in West Chester each December. This ballet continues to be our highest grossing production, and 2015 continued this growing trend. The quality of the ballet, and the number of audience members continually exceed expectations. The Nutcracker ballet helps people to ring in the holiday season, bringing families and friends together for a shared experience. Dancers, from the smallest to the most seasoned, share the stage and show children, both in the production and in the audience, that they can achieve their goals and dreams like the professional dancers on the stage.

A twist on the original tale, Ms. Page decided to have the characters of Tin Man, Scarecrow, and Cowardly Lion to be accompanied by a Tin Woman, Scarecrow Woman, and Cowardly Lioness Dorothy and her faithful friends along with the help of the Good Witch, banish the Wicked Witch from the realm, restoring peace to all those who live there. This production brought a renewed sense of childhood magic and imagination to our dancers and audiences.

The company also appears in additional performances through participation in local festivals. Brandywine Ballet believes in enriching our student dancers lives, which is why we provide special weekly classes for our dancers, and we work hard to provide them with challenging performance opportunities.
