DEVELOPMENT OF FUNDING AND PROVISION OF SUPPORT FOR AFFILIATED ORGANIZATIONS. DURING THE FISCAL YEAR, THE ORGANIZATION RAISED APPROXIMATELY \$335,000 TO BENEFIT RESIDENTS WHO WERE IN NEED OF FINANCIAL ASSISTANCE. ADDITIONALLY, FUNDS WERE USED FOR FACILITIES MAINTENANCE AND TO PROVIDE EDUCATIONAL OPPORTUNITIES FOR SENIORS. GIFTS WERE RECEIVED FROM 261 NEW DONORS.
