AWARDED ANNUALLY AND BY SCHOOL TERM, SCHOLARSHIPS ARE FUNDED BY DONATIONS FROM CORPORATIONS, FOUNDATIONS, INDIVIDUALS AND ORGANIZATIONS AS WELL AS PROCEEDS FROM THE ANNUAL MHCC FOUNDATION AUCTION. ONCE FUNDING IS AVAILABLE, SCHOLARSHIPS ARE ADVERTISED FOR STUDENT APPLICATION. A MHCC FINANCIAL AID REPRESENTATIVE AND THE MHCCD FOUNDATION SCHOLARSHIP AND GRANTS COMMITTEE MEMBERS REVIEW THE APPLICATIONS AND DETERMINE A RECIPIENT BASED UPON THE ESTABLISHED SCHOLARSHIP CRITERIA. APPROXIMATELY \$211,072 WAS AWARDED TO APPROXIMATELY 126 STUDENTS IN THE 2015-2016 FISCAL YEAR. THESE SCHOLARSHIP AWARDS AID STUDENTS IN PAYING FOR TUITION, FEES, BOOKS, AND SUPPORT SERVICES.

TYPICALLY THE COLLEGE PRESIDENT MAKES THE REQUEST. IN 2015-2016, THE FOUNDATION SUPPORTED THE COLLEGE WITH PAYMENTS OR TRANSFERS FROM THE BOARD DESIGNATED GENERAL FUND TOTALLING \$164,588 TO BE USED FOR SOFTWARE, EQUIPMENT, TESTING, BUILDING REPAIRS, EDUCATIONAL RESOURCES AND A DIVERSITY OFFICER.
