UNIQUE COMPONENTS OF THIS TREATMENT INCLUDE THERAPEUTIC INDIVIDUALIZED PHASES FOR SUCCESSSES (A BEHAVIOR MANAGEMENT PROGRAM) AND STRUCTURED LEISURE, RECREATION, AND EDUCATIONAL ENRICHMENT ACTIVITIES.
